This letter is a revision to the letter dated June 30, 2011, as it was brought to our attention that modified product was submitted for this review. This product was submitted separately from the reconsideration request and did not reference the xref # of the reconsideration; therefore, it was not initially part of the reconsideration review.

We reviewed your request for a reconsideration of our coding verification decision for the above listed products. It is our determination that the Medicare Healthcare Common Procedural Coding System (HCPCS) codes to use to bill the four Durable Medical Equipment Medicare Administrative Contractors (DME MACs) are:

L0637 - LUMBAR-SACRAL ORTHOSIS, SAGITTAL-CORONAL CONTROL, WITH RIGID ANTERIOR AND POSTERIOR FRAME/PANELS, POSTERIOR EXTENDS FROM SACROCOCCYGEAL JUNCTION TO T-9 VERTEBRA, LATERAL STRENGTH PROVIDED BY RIGID LATERAL FRAME/PANELS, PRODUCES INTRACAVITARY PRESSURE TO REDUCE LOAD ON INTERVERTEBRAL DISCS, INCLUDES STRAPS, CLOSURES, MAY INCLUDE PADDING, SHOULDER STRAPS, PENDULOUS ABDOMEN DESIGN, PREFABRICATED, INCLUDES FITTING AND ADJUSTMENT (For SLEEQ APL model numbers 901300, 901301, 901302, 901303, 901304, 901305, 901306, 901307, 901308, 901309, 901310)
