Instructions for Use

Indications

- · Chronic elbow injuries
- · Elbow hyperextension
- · Elbow dislocations
- · Range of motion control
- · Bicep tendon strain, rupture or tear
- · Stable mid-shaft or distal humeral fracture
- · Stable mid-shaft or proximal ulna or radius fracture
- · Mild to severe soft tissue damage
- · Post-operative elbow surgery to include the Tommy John UCL procedure
- · Mild to severe elbow joint laxity
- · Post-operative partial or total elbow replacement
- · Distal triceps tendon strain, rupture or tear

Contraindications

- · Unstable humeral fracture
- · Proximal humeral fracture

- · Unstable ulna or radius fracture
- · Distal ulna or radius fracture

If the patient experiences any problems, increased pain, swelling, numbing, skin irritations, or any other adverse reaction while using the product, discontinue use immediatly and contact their medical professional. Instructions for Care



Remove pads and hand wash 30°C with mild detergent



Do not




Lay pads flat to dry



Do not submerge uprights and hinge in water

Fitting Instructions Brace Components (EE)

- 1. Straps
- 2. Strap buckles
- 3. Upper and lower shells
- 4. Upper and lower interface pads
- 5. Hinge cap & screws
- 6. C/S Package
- 7. Moldable metal cuffs
- 8. Condyle pads
- 9. CS strap





1. Unfasten straps (A)

Unfasten ALL straps and fold the attachment tabs back onto the strap.

2. Fit moldable cuffs to arm

On a flat surface place the arm into the brace and mold the top and bottom metal cuffs for a close fit. **(B)**


Remove the brace and re-mold the cuffs to fit snug as needed. **(C)**

3. Apply the brace (D)

On a flat surface and insert the arm into the brace. Be sure the inner crease of the elbow is in alignment with the center of the hinge. Unfasten the attachment tabs from the strap and insert the ends through the buckles in the recommended order (1-4). Distal to proximal.


Straps must be tightened snugly, but still be comfortable. Re-adjust as necessary with activity.





To maximize suspension and fit, CS strap may be adjusted during initial

NOTE: Strap does not need to be opened to remove or reapply brace.



4. Adjusting Range of Motion (E)

Brace is shipped with extension screws installed at 15°. Additional flexion and extension ROM points are available on the hinge. To change, use a size 15 Torx wrench (included) to remove screws and place them in the desired stop. Use the wrench to ensure they are seated and secured before use. **Both hinges must be set to identical degrees.**

Warranty

Under normal use and conditions, the shells and hinges on your brace are covered by a one year warranty against defects or breaking. Straps, hinge covers, and other replaceable parts are covered for six months. If you experience a problem with the fit or function of the brace, please call the medical provider who fit your brace.

Limited Warranty Thuasne USA warrants to the original purchaser that this product is free from defects in materials and workmanship. Normal wear and tear during the use of a product is not considered a defect. This Limited Warranty is effective from the date of delivery to the original purchaser for up to 6 months.
